MEMORANDUM OF UNDERSTANDING AGREEMENT

Between

PMFNCNP A-1/22, Hastal Road, Uttam Nagar, New Delhi - 110059 (Hereinafter referred to as the "First Party")

And

Dr. Paresh Vamanrao Dave, Charotar Education Society (CES), D.N. High School Campus, Hastal Road, Anand-388001, Gujarat India

[Full Name and Address of the Institute] (Hereinafter referred to as the "Second Party")

This Memorandum of Understanding (MoU) is made and entered into on this ____ day of _____ by and between the above parties for the purpose of collaboration to conduct self-job oriented paramedical courses offered by the First Party at the premises of the Second Party, which shall function as a branch of the First Party.

WHEREAS:

- (1) The First Party is an autonomous private organization operating as an ISO Certified NGO registered under Trust Act 1821 by Govt. Of NCT, Delhi and recorded with NITI Aayog & National Career Mission - Ministry of Labour & Employment, Govt of India conducting self-job oriented courses for the enhancement of knowledge and wisdom in the field of paramedical sciences.
- (2) The Second Party is desirous of collaborating with the First Party to conduct the said paramedical courses at its premises, under the academic and administrative supervision of the First Party.

WHEREAS, the parties agreed to work for enhancement of Paramedical Education on the term & conditions mentioned below:-

Responsibilities of the First Party:

Design and determine the curriculum and syllabus of all paramedical courses to be offered.
Handle student enrollment and maintain student records.
Prepare examination question papers and conduct assessments.
Evaluate answer sheets, declare results, and issue performance certificates to successful candidates.
Monitor academic quality through feedback and periodic visits.
Provide a schedule for theory and practical examinations.

Responsibilities of the Second Party:

Handwritten signature

provide suitable premises and facilities to conduct classes.
appoint qualified faculty members as per the curriculum requirements.
conduct theoretical classes and coordinate practical training as per First Party guidelines.
administer examinations at its location according to the schedule and procedures set by the First Party.
distribute performance certificates provided by the First Party.
submit monthly reports, including attendance and progress reports of students, to the First Party.

Second Party will be called as Branch of **PMFNCP** at address mentioned above which will be used for Training of PMFNCP courses and any change in present premises will be communicated immediately to the first party subject to approval otherwise MOU will be treated cancelled

Second Party shall maintain the standard of the courses as per the norms and guidelines issued by time to time and fully bound to comply with order issued by the First party regarding syllabus, attendance, examination, result, projects and staff, etc.

Minimum 80% attendance must in Theory and 95% in Practical Training. The Second Party should have to do at least one Charitable activity on monthly/two monthly basis.

Admissions per batch and per course shall be restricted to the sanctioned intakes and shall not exceed the from approved limit. No forms will be accepted by the First Party extra then sanctioned courses.

That the final/supplementary examination will conducted by the First Party at the said Branch or any other suitable place in the area.

First Party shall monitor the standard of the courses regularly by way of feedback received from the participants and visit by First party's nominee to assess the standard directly. Such visit will be made at the cost of the approved branch. Minimum of one visit will be made in respect of each programme.

Second Party shall pay the Non-refundable security fee to the First Party as mentioned in the guidelines. The amount has to be send to the Secretary of the first Party within a week from the date of commencement of the course along with details of enrolled the candidates.

Operational Guidelines:

the Second Party shall function as an authorized Branch of the First Party.
the Second Party shall take full responsibility for the management, discipline, and operations of the branch.
any change in premises shall require prior written approval of the First Party.
the Second Party shall ensure all enrolled students sign a declaration acknowledging:

- * Awareness of the autonomous and non-recognized nature of the courses.
- * That the courses are not valid for government/private employment or further academic pursuits.
- * That no claims will be made regarding scholarships, bus passes, or job guarantees.

Second Party will be responsible of giving local state / district, agreement of faculty / practical sessions maintain attendance register / follow each and every activity of NCP. Advertisement, course to be organized by them. They have to submit monthly report of registered students and this report include attendance sheet (Theory/Practical).

It should be very clearly noted that any types of fee sharing/charges / once paid, is neither refundable nor adjustable in any circumstances. The Second will not be responsible for any changes in circumstances of training, economic conditions, conflicts or disputes with Management/member/ candidates registered at the Branch or in any other reason.

The Branch Should approval for a period of one year only and which may be extended based on the progress to be assessed by the First Party. Second Party only be extended on the basis of previous year record in which **minimum strength of 30 student** is the compulsory condition which havr to full fill the Second Party for extension of the Branch and also for examination



centre.

First Party reserves the right to withdraw the approval of the branch at any point of time, without assigning any reason thereof, in case the First Party finds that the Second Party has deviated from any of the term and conditions.

Second Party shall agree to abide all terms and conditions mentioned above which may be framed by First Party from time to time in order to maintain high standards of training.

Prior Approval of First Party will be required for all advertisement given by Second Party and if the Second Party fails to do so, it results cancellation of approval of the Branch.

The Second Party will ensure to attach declaration form signed by candidate stating:

- (i) I Know very well that **PMFNCP** is an Autonomous NGO registered under Trust Act and running self-job oriented courses only for knowledge and wisdom.
- (ii) No Assurance of validity of certificates given by PMFNCP or its Branch in Govt./ Private job or in further education.
- (iii) I have taken admission in PMFNCP course at its Branch for enhancement of knowledge & Wisdom only and I will never claim for any type of "Scholarship, Bus Passes and PMFNCP Branch never given any guarantee in this regard". Failing to do so enrolment forms of the individual or all student of the Branch will be rejected and also be suspended / cancel approval of the Branch.

Legal and Administrative Clauses:

- a. The First Party shall not be responsible in any way for any activities or legal issues arising out of the conduct of the Second Party.
- b. The Second Party assumes full liability for any dispute, misrepresentation, or malpractice arising within its branch.
- c. This MoU is valid for one year and is renewable subject to satisfactory performance and approval from the First Party.
- d. In case of any legal dispute, the jurisdiction shall lie exclusively in Delhi and be resolved through mediation or arbitration as per law.


