1. **Medilink Institute Of Nursing Sciences** will be responsible to arrange affiliation, recognition and certification from Gujarat university, Gujarat nursing council, Indian nursing council, state government and other legal authorities from time to time as well as recruit professors, tutor, teaching, technical and administrative staff for their own college of nursing and create all other facilities to provide academic training of the required curriculum programme at their own premises.

3. The parties have thus entered into this Memorandum of Understanding on the terms as recorded hereinafter.

**NOW THIS MEMORANDUM OF UNDERSTANDING WITNESS AS UNDER:**

1. **Medilink Institute Of Nursing Sciences** shall be responsible for procurement and maintenance of affiliation and recognition from Gujarat university, Gujarat nursing council, Indian nursing council and other legal authorities including state government from time to time; wherein the **DR. JIVRAJ MEHTA HOSPITAL** will not be responsible or will not be liable for any de-recognition of the **Medilink Institute Of Nursing Sciences**. indemnifies **DR. JIVRAJ MEHTA HOSPITAL** for any loss which may be caused due to non receipt of the requisite approval/permission.
2. After due approval of authorities as stated in (1) above, the teaching activities shall come in to effect and **Medilink Institute Of Nursing Sciences** shall notify **DR. JIVRAJ MEHTA HOSPITAL** in writing in advance, i.e. 10 days before proposed training schedule, about the schedule, Students list or details (number of students), time tables and training related activities including clinical examination.
